This letter is a formal request for the preservation of records and evidence related to phone number 17186x8424 which is registered through your services. This request is made in connection with an official investigation into a criminal matter. The aforementioned number 17186x8424 was used by the suspect to facilitate a BURGLARY. The primary period of activity under investigation is from December 20, 2025, to the present.

Pursuant to the Stored Communications Act, 18 U.S.C. § 2703(f), we request that you immediately take all necessary steps to preserve any and all records associated with the number 17186x8424 for a period of 90 days from the date of this letter, pending the issuance of a search warrant, subpoena, or other legal process.

• Subscriber & Registrant Information :

- o The full name, physical address(es), telephone number(s), and email address(es) of the registrant and any associated contacts (administrative, technical, billing).
- o All historical registrant data associated with the account.

• Account & Billing Records :

- o The date and time the account was created.
- o All payment information on file, including credit card details (e.g., cardholder name, last four digits, expiration date, and billing address), bank account information, or other payment methods used to maintain the account.

• Call Detail Records & Location Data :

- o All call detail records, including dialed and received numbers, dates, times, durations, and cell-site/sector information.
- o Specialized location records, including but not limited to NELOS, RTT, PCMD, TDOA, and E9-1-1 location data.

• Stored Communications & Content :

- o The contents of all text messages, emails, and other electronically stored communications.

o All files, images, videos, and documents stored in any associated cloud account.

This request is solely for the preservation of data and is not a request for the disclosure of records at this time. Please do not delete, alter, or otherwise dispose of the requested information.
